



Curriculum and Assessment (Wales) Act 2021

Concluding Observations

- Each element of research informed practice involves making values-based judgments
- Children's rights encompass fundamental values around personhood, recognition, agency, equality and dignity, as well as specifics around special vulnerabilities and fulfilment of needs
- Welsh law is building a values-based framework derived from children's rights. This is well-established, and ongoing.
- Research, meaning-making and practice, here and now, must, by law, operationalise children's rights.
- All of which means that children's rights are part of the knowledge bank on which practitioners must draw, provide a lens through which to make meaning of information derived from research, and govern what practitioners do.
- Continual learning is needed, best done collaboratively, linking law makers, policy officials, researchers, practitioners and service users.
- So CREYN is essential!!
