Children in Wales - Plant yng Nghymru

Introduction

Children in Wales is the national umbrella organisation for voluntary, statutory and professional organisations and individuals who work with children, young people and families in Wales. Our aim is to promote the interests of these groups and take action to meet their needs by:

- Contributing to making children's rights a reality in Wales
- Fighting for sustainable quality services and fair shares for all children and young people
- Ensuring special attention and treatment for children in need and those who are marginalised
- Ensuring children and young people have a voice

Children in Wales is a membership organisation and provides a range of services designed to keep members informed of new developments and to facilitate joint responses. We are a registered charity and an independent, non-governmental organisation. We are also funded under the Children and Families Development Grant from the Welsh Government on a three year project to reduce inequalities in health,



education and economic outcomes for children living in poverty, working under the following objectives:

- Informing and enabling children and young people to participate effectively and have their views heard by Ministers and policy makers
- Ensuring that the children and young people's workforce is informed of children's right to participate and for structures to be in place that facilitate the sharing of effective methods of participation
- Supporting a better informed and engaged multi agency cross sector workforce including policy makers and practitioners to deliver Welsh Government Policy
- Effectively influencing and contributing to policy and practice development with an emphasis on early intervention, prevention and mitigation of poverty, underpinned by Welsh Government strategic priorities



Better connected children and young people

Young Wales is Children in Wales' participation initiative, funded under the Welsh Government's Children and Families Delivery Grant. During 2016-17, we establshed the Young People's Project Board who shape the work of Young Wales going foward. We work on the following priorities, indentified as areas of importance and voted on by youth forum members at the start of the project.

Emotional Well-being and mental health

Mental health has always been one of Young Wales' priorities. Identified as a key priority by local youth forums, mental health and emotional well-being continues to be raised as an issue by young people. Young Wales. This theme feeds in to the Together for Children and Young People programme.

Young Wales has created a group looking at mental health. The Young Person's Emotional Well-being and Mental Health Group was established in October 2016. The Group aims to give young people opportunities to:

- Give their views on emotional well-being and mental health issues facing young people in Wales
- Get their opinions heard by Together for Children and Young People
- Get their ideas heard by Welsh Government on how to ensure well-being is at the heart of the new curriculum

The group met in December and January to discuss a new leaflet being developed by the Together for Children and Young People (T4CYP) Programme to help children understand what to expect if they are referred to CAMHS.

The Well-being of Future Generations

The Well-being of Future Generations has been identified as one of Young Wales' priorities for the year. This work looks at improving cultural, economic, environmental and social well-being in Wales and its sustainability long-term. Young Wales' work in this area will focus on climate change

30 young people from across Wales attended a meeting with Sophie Howe, the Future Generations Commissioner in early January. The Question and Answer allowed the Commissioner to update young people on the Future Generations Act and the work she is planning, using the 7 wellbeing Goals and the 5 ways of working.

Anti-Bullying and hate crime

Anti-bullying continues to be a key priority for young people who identify bullying as a huge area of concern. Young people feel that more education and awareness is needed of the effects of bullying and stronger links between communities, community services and schools to best prevent bullying and tackle its effects.

Young Wales facilitates an Anti-Bullying Network which met throughout the year and aims to work together with the Preventing Bullying Behaviour Group at Welsh Government, and other organisations, to promote anti-bullying messages and a rights-based approach to anti-bullying work. The group developed a survey to support Anti-Bullying Week this year. Young Wales has also consulted with young people for the Welsh Government's review of the Respecting Others anti-bullying guidance.

Young Wales organised a free forum theatre workshop for young people. The production, called 'Real Human Being' focused on bullying and disability hate crime, including the role of the by-stander. The workshop was held to coincide with national antibullying week, which highlights issues in this area. Young Wales worked in partnership with Taking Flight Theatre Company and Atradius UK who spon-sored the day.





Curriculum development

Young people have identified curriculum development as one of Young Wales' priorities. Domestic abuse and healthy relationships continue to have a strong focus in the Young Wales work programme, with specific links to the developments within the new curriculum and PSE.

Young Wales is a member of the strategic stakeholder sub group on Children and young people, ensur-ing young people's voices are heard in the development and implementation of the new curriculum. At the last meeting we identified that there is a need to ensure that the views and voices of the chil-dren and young people who are home schooled are included in discussions. Young Wales will support this work alongside one of the members of the Young Wales Project Board.

UNCRC

Young people continue to identify children's rights as a key priority in Young Wales' work. Specifically, young people feel that awareness and education around children's rights need to improve to ensure that all children and young people know about their rights and how to access them.

In May 2016, Young Wales attended a session in Geneva as part of the reporting process on children's rights, where the UK Government responded to issues raised in the evidence sessions. delegates from Merthyr Tydfil Youth Forum and Voices from Care Cymru were given the opportunity to give evi-dence directly to members of the Committee on a range of concerns for children and young people.

UK Youth Parliament

On 11 November 2016, Young Wales supported 18 Welsh Members of the UK Youth Parliament to take part in the annual Youth Parliament debate in the House of Commons Chamber. Ahead of the event, training and a mock debate were held to help prepare the young people for the day. 276 elected members of UK Youth Parliament (aged 1118) from across the UK debated the top issues affecting young people, as voted on by young people at the event. Chaired by the Speaker of the House of Commons, Rt Hon John Bercow MP, Members of Youth Parliament voted to campaign on votes at 16 and a curriculum for life in 2017.

Young Wales Annual Conference

Over 120 young people from across Wales joined us at our second Annual Conference held in Cardiff during half-term on Tuesday, 21 February 2017. The conference was planned and delivered by young people from the Young People's Project Board who shape and lead the work of Young Wales. Samuel Taylor and Fateha Ali chaired the event.

Approximately 50% of the young participants were from youth forums and councils from across Wales. All young people at the Conference had the opportunity to participate in four workshops throughout the day. In the afternoon, there was a video message from Carl Sargeant, AM and Cabinet Secretary for Communities and Children, and a presentation by the Children's Commissioner for Wales.

Better connected families and workforce



Children in Wales facilitates networks which bring professionals together to discuss policy and practice issues. Through these networks we inform members of new developments, share good practice and develop appropriate perspectives on policy developments.

Cywaith Management Board

Children in Wales chairs the Cywaith Management Board, a collaborative partnership of five organisations. Cywaith has responsibility for overseeing the management, operation and delivery of the MEIC information and support service for children and young people.

Advocacy Practice Exchange Group

The Advocacy Practice Exchange Group provides an opportunity for practitioners in the field to share practice, experience and knowledge about advocacy and related areas. It contributes to the improved development of advocacy practice across Wales.

All Wales Children and Young People's Advocacy Providers' Network

The All Wales Children and Young People's Advocacy

Providers' Network contributes to and supports the development of effective advocacy in Wales. It aims to promote partnership work and developmental strategies between organisations.

Third Sector Additional Needs Alliance (TSANA)

Children in Wales Chairs the Third Sector Additional Needs Alliance (TSANA). This is a group of voluntary organisations which seek to protect and promote the rights of children with additional needs in Wales. The aim of the group is to work with the National Assembly for Wales and Welsh Government to influence policy, to ensure that children with additional needs reach their full potential.

Forum for Integrated Service Delivery

The Forum for Integrated Service Delivery brings together professionals across Wales who are leading the development of the Team Around the Family, as part of the Welsh Government's Families First programme. The aim of the forum is to offer peer support to managers involved in developing local services.

Parenting Co-ordinators' Network

The Parenting Co-ordinators' Network is a network for those who have a strategic co-ordinating role for parenting support in their Local Authority. The quarterly meetings give co-ordinators a chance to share issues, solutions, research and policy with their colleagues.

Preventing Bullying Behaviour Group

Children in Wales' Preventing Bullying Behaviour Group aims to ensure that policies relating to the antibullying agenda, both in schools and communities, are evaluated and joined up. The group supports antibullying work nationally and locally. It also provides an opportunity to share practice and identify common concerns.

End Child Poverty Network Cymru

The End Child Poverty Network Cymru is a coalition of organisations concerned with child poverty. It was set up in November 2001 and works to increase public and professional understanding of child poverty in Wales and measures to end it. It lobbies for policies at all levels of government which contribute to ending child poverty in Wales.

Flying Start Managers' Network

The Flying Start Network meets quarterly, bringing together the Flying Start Managers from the 22 Local Authorities. Additional meetings and workshops are also organised as needed. The Flying Start Network includes all managers of the programme in Local Authorities as well as Welsh Government managers.

Young Carers Workers' Network

The Young Carers Workers' Network is open to all those who work with young carers in Wales. The Network shares issues, concerns and supports the development of good practice. The Network also supports a young carers network who meet to identify key issues of concern and has the opportunity to present their concerns to the Deputy Minister for Social Services on an annual basis.



Influencing practice, policy development and research

Talk, Learn, Do: Parents, Kids and Money


Children in Wales facilitated a pilot study into financial capability called Talk, Learn, Do: Parents, Kids and Money. The project started in October 2015 and was led by the Money Advice Service, Children in Wales and other partners.

Direct delivery of Talk, Learn Do ended in April 2017 along with the coordination of the project by Children in Wales. To celebrate the work of practitioners who delivered the programme they organised two events during March in Cardiff and Wrexham.

The Money Advice Service has agreed to let partners deliver further Talk, Learn, Do sessions during the summer term 2017, and make the session materials available between now and the end of the impact evaluation in 2018.

The Money Advice Service will continue to work closely with delivery partners and look towards securing a legacy by using feedback from the back to feed into the National Advice Network, promote resources developed for the pilot project, and support financial capability as part of parenting programmes where it is most needed.

Getting More Involved in Social Care project The Getting More Involved in Social Care project is a new initiative being developed by Children in





Wales. It is a three year project funded by Welsh Government, looking at supporting the health and well-being of looked after children, disabled children and young people and kinship carers.

The project started in April 2016. Children in Wales is working with looked after children, disabled children and kinship carers to produce online guides that will inform young people of their rights under the United Nations Convention on the Rights of the Child (UNCRC) and to bring groups together for mutual support and learning.

Keep Kids Safe 2017

Children in Wales, in partnership with Public Health Wales, developed a new child safety toolkit for 2017. Aimed at reducing unintentional injuries in the under 5s, this exciting new toolkit provides your organisation and practitioners with all of the resources needed to deliver a whole year of child safety information and advice to parents.

The Keep Kids Safe toolkit was developed to address the needs of practitioners, who stated: "We know we should do something, but we haven't got the time to develop anything and we're not sure what to do or how to address it. We need something we can pick up and run with." Issues addressed in the toolkit include nicotine poisoning, falls, scalds, blind cords and nappy sacks.

Child and Family Poverty in Wales: Results from the Child and Family Survey 2016

Following our report on child and family poverty in 2014 and follow-up survey in 2015, we surveyed members and the wider workforce again this year, revisiting the issues that were raised to find out whether things had changed since the publication of the report.

In March 2017 year, we published a summary of the results from this work in Child and Family Poverty in Wales: Results from the Child and Family Survey 2016. This report is divided into six sections focused on the following themes: tThe impact of welfare reform, food poverty, debt, insecure employment and income, housing, and the 'poverty premium'. The report also details additional issues which have affected households since the original survey. **Children with Additional Learning Needs** Children in Wales is chair of TSANA (The Third Sector Additional Needs Alliance) a group of voluntary organisations which seek to protect and promote the rights of children with additional needs in Wales

Throughout 2016/17 Children in Wales continued to work in this role with the Welsh Government and other organisations to influence legislation, policy and practice in Wales to ensure that children with additional needs can access the support they need to reach their full potential. This included meeting with Welsh Government officials to help shape the development of the Additional Learning Needs and Education Tribunal (wales) Bill.

Refresh of the Participation Standards for Wales

Children in Wales worked with Youth Forum participation workers to create a refreshed version of the Welsh Government's Participation Standards, which set out the key areas that professionals and organisations should be aware of when working with children and young people in Wales. The refreshed standards were published in November 2017.

Youth Forum Participation workers and Young Wales worked on revising the standards in line with ideas and insight collected during consultation with young people across the country. The seven standards link clearly to the Children's Rights agenda in Wales.

The standards will be followed up with revised guidance on the kite-marking process and the selfassessment tools, for use in local authorities which have an inspection team.

Organisations working with children and young people will be encouraged to undertake the selfassessment process to demonstrate they the meet the Participation Standards in all their work with children and young people.

The website also allows us to share information on Young Wales' work and opportunities for young people to get involved and have their voices heard.

Children in Wales magazine

Children in Wales' magazine is published on a quarterly basis. It provides a round-up of the policy developments from the National Assembly for Wales and the UK Parliament, as well as the latest news from Children in Wales and our members. It contains in-depth features and interviews on important topics and regular columns from the Children's Commissioner for Wales and MEIC Cymru.



Briefing papers

Children in Wales prepares and distributes briefings on speicific topics for our members. These give more detailed information on laws and policies.

During 2016-17, we wrote breifinngs on the work of the Fifth Assembly, and Taking Wales Forward, the Welsh Government's Programme for Government.

E-briefing services

Children in Wales produces a number of electronic briefings for our members and networks.

Our members' e-briefing is circulated weekly. It keeps our members up-to-date with the latest policy developments and news.

The Young Wales newletter is sent out monthly with the latest news and information for young people and participation workers.

Legislation

Regulation and Inspection of Social Care (Wales) Act

The Regulation and Inspection of Social Care (Wales) Act 2016 received Royal Assent on 18 January 2016. This Act from the National Assembly for Wales makes provision for the registration and regulation of person providing social care services, including reside ential family vices, adoption services, fostering services and advocacy services.

The Art also renames the Care Council for Wales as Social The Act also renames the Care Council for Wales as Social Care Wales, which will provide advice and assistance to persons providing services involving care and support in terms of registration, regulation and training of social

Violence (Wales) Act 2015

The Violence against Women, Domestic Abuse and Sexual Violence (Wales) Act 2015 received Royal Assent on 29 April 2015. The aims of the Act are to improve arrangements for the prevention of gender-based violence, domestic abuse and sexual violence; to improve ments and support for the protection of victims: and to create the post of National Adviser on gender based violence, domestic abuse and sexual violence.

and implement a national strategy for tackling violence against women, and a duty on local authorities to produce and implement local strategies. It also contains provisions on measuring performance under the Act, and on new powers to implement regulations on information for educational purposes.

Well-being of Future Generations (Wales) Act 2015 The Well-being of Future Generations (Wales) Act received Royal Assent on 29 April 2015. The Act requ public bodies to actively pursue environmental, socia cultural and economic sustainability. uires nental, social,

The Act contains provisions duties on well-being goals

and objectives. It sets goals for well-being in the pre and future, and also set out how public authorities will show they are working towards those goals. Th Act puts Public Service Boards on a statutory footing and simplifies requirements for integrated commun planning

The Act also establishes the office of the Futur enerations Commiss er for Wales, who will support the Welsh Government and Welsh public authorities in meeting these goals and advocate for future generations.

Higher Education (Wales) Act 2015 The Higher Education (Wales) Act received Royal Assent on 12 March 2015. It makes provision on fees and access plans for Higher Education, and also assessment and quality of education in Higher Education.

Act also introdue es a duty to on code on the financial affairs of Higher Educa stablishments.

alifications Wales Act 2015

The Qualification Wales Act received Royal Assent on 5 August 2015.The Act establishes a new body, Qualifications Wales, to be the independent regulatory body for non-degree qualifications in Wales.

This is intended to address weakness in the current system, by ensuring that one organisation takes responsibility for qualifications; giving powers to prioritise qualifications and to ensure that students across Wales take the same gualification; and providing more capacity for strategic development of qualifications

The Act provides Qualifications Wales with the following

- Ensuring that qualifications, and the Welsh qualification system, are effective for meeting the reasonable needs of learners in Wales
 Promoting public confidence in qualifications and in the Welsh qualification system.

Children in Wales Preventing Bullying Behaviour Group – Bullying is... anyone going to care? 6 October 2016, Cardiff


Our anti-bully event gave attendees the chance to tell us about their thoughts on how to improve antibullying work across Wales.

The Family Information Services Conference, 15 March 2017, Cardiff

This conference looked at the current developments that will shape Family Information Services in the coming year including Adverse Childhood Experiences, the development of Children's Zones, the roll out of childcare services and recent developments in parenting support.

Training



Children in Wales provides multi-disciplinary training courses which aim to promote an integrated approach for all those working in the statutory, third and independent sectors. The courses draw on the resources of our own specialist staff team, and a national network of expert individuals and organisations, to deliver high quality training events at a variety of venues across Wales. Our training courses are aimed at people working in Wales, and reflect the Welsh context.

Open training

During 2016-17, Children in Wales ran a comprehensive programme of 78 open training courses. Our training programme featured an ambitious range of topics, including safeguarding, child sexual exploitation, putting participation into practice, reducing home accidents in the early years, cultural awareness in safeguarding, harmful traditional practices, working with young LGBTQ people and motivational interviewing. Accreditation

We are able to offer accredited training courses on a range of topics with Agored Cymru as our awarding body. We continue to receive excellent reports from Agored Cymru with the Quality Reviewers noting::

Commissioned training

Children in Wales provides commissioned training for organisations wanting a course that is tailored to their needs.

Core topics that Children in Wales provide training on include child protection at different levels ranging from basic 'awareness raising' to courses aimed at those providing a Designated Person role. Other popular courses are Cultural Awareness, Children's Rights and Participation, Building Resilience in Young People, and E-Safety. We also develop more bespoke training if the topic required is not on our standard programme. We provided 82 commissioned training courses during 2016-17.

Child protection training for dental practitioners

Children in Wales continues the successful programme to deliver child protection training to all staff within dental practices and at Post-graduate Centres in Wales. We are contracted to provide Level 2 Child Protection training for the Wales Deanery for Post-graduate Education for Dentists. We delivered 55 child protection training sessions to dental practitioners across Wales between April 2016 and March 2017.

Child and Family Delivery Grant - Welsh Government

Under this Welsh Government grant the training team delivered 8 free sessions across Wales to increase awareness and skills in participative techniques when working with children and young people.

In addition, we delivered four free sessions called The Bigger Picture exploring child and family policy and legislation. These multi-agency workshops were aimed at supporting a range of organisations to have greater understanding of how their work fits into the wider policy context evolving in Wales.

Social Services and Well-being (Wales) Act

Children in Wales delivered five traiing sessions for local authorities on the social Services and Wellbeing (Wales) Act, along with two sessons for Family Information Services.

Soft Outcomes and Distance Measured

Children in Wales delivered three sessions of training on soft outcomes and distance measured for the Welsh Council for Voluntary Action between October-December 2016.
