Language Requirement: This role requires a high level of fluency in Welsh. The ability to communicate confidently and professionally through the medium of Welsh is essential.

Main purpose of role:

The Sessional Development Officer - Participation (Welsh Medium) will support the delivery of Children in Wales' participation and children's rights work, primarily through Welsh-language engagement with children and young people, and the organisations and professionals who support them. This includes contributing to Cymru Ifanc – Young Wales, and the organisation's broader public education and policy agenda.

Main duties and responsibilities

Young Wales

- Plan and deliver participation sessions and consultations through the medium of Welsh with children and young people across Wales.
- Engage children and young people in Welsh-medium settings and communities to ensure their voices are represented in policy and practice.
- Work with partner organisations to promote a children's rights approach and encourage bilingual or Welsh-medium participation activities.
- Coordinate and facilitate meetings, workshops, and youth-led events in Welsh.
- Develop and translate resources, reports, and promotional materials into Welsh.
- Support the production and dissemination of consultation reports and summaries for various audiences, including children, professionals, and decision-makers.

Policy Development (Welsh Contribution)

- Gather and analyse feedback from Welsh-speaking children and young people to inform policy development.
- Contribute to policy briefings and consultation responses by incorporating the perspectives of Welsh-speaking participants.
- Work collaboratively with the policy team to identify key issues emerging from Welshspeaking communities and networks.

Partnership Working and Practice Sharing

- Build and maintain strong relationships with practitioners and organisations working in Welsh-speaking communities or Welsh-medium settings.
- Share good practice examples of participation work carried out in Welsh.
- Represent Children in Wales in relevant meetings, networks, and events where Welshmedium expertise is required.

Flexible Project Delivery

- Support the organisation's wider aims and projects on a sessional basis, contributing time flexibly to meet agreed deadlines and priorities.
- Undertake administrative duties related to sessional work (e.g. scheduling, reporting, data recording).
- Ensure all work delivered complies with safeguarding, inclusion, and equality policies.

This list is not exhaustive as there may be other duties and responsibilities, which Children in Wales may require the post-holder to perform from time to time in contributing to the delivery of its activities.

Person Specification

The post holder will be required to travel to events and meetings across Wales.

Key Requirements – Essential

- 1. Fluent Welsh speaker and writer, confident in delivering professional and youth-facing communications in Welsh.
- 2. Experience of working with children and young people, preferably in participation or youth engagement roles.
- 3. Knowledge of Safeguarding in practice including contextual and digital safeguarding and a commitment to continuous learning and development in this area.
- 4. Understanding of children's rights, especially the UNCRC.
- 5. Commitment to inclusive practice
- 6. Good interpersonal, relationship building and organisational skills.
- 7. Experience of data collection and analysis
- 8. Able to work flexibly, independently and as part of a team.
- 9. Able to prioritise and meet deadlines
- 10. Able to represent Children in Wales with external audiences.

Background Information

Children in Wales – Plant yng Nghymru is the national representative membership organisation for individuals and organisations from all sectors who work with children, young people and families in Wales. Our membership is drawn from the public-, charitable/not-for-profit- and independent-sectors. Our work will be underpinned by a collaborative approach, which facilitates opportunities for our members, children and young people.
