Introduction

Children in Wales is the national umbrella organisation for voluntary, statutory and professional organisations and individuals who work with children, young people and families in Wales. Our aim is to promote the interests of these groups and take action to meet their needs by:

- Contributing to making children's rights a reality in Wales
- Fighting for sustainable quality services and fair shares for all children and young people
- Ensuring special attention and treatment for children in need and those who are marginalised
- Ensuring children and young people have a voice

Children in Wales is a membership organisation and provides a range of services designed to keep members informed of new developments and to facilitate joint responses. We are a registered charity and an independent, non-governmental organisation. We are also funded under the Children and Families Development Grant from the Welsh Government from October for a three year project to reduce inequalities in health, education and economic outcomes for children living in poverty, working under the following objectives:

- Informing and enabling children and young people to participate effectively and have their views heard by Ministers and policy makers
- Ensuring that the children and young people's workforce is informed of children's right to participate and for structures to be in place that facilitate the sharing of effective methods of participation
- Supporting a better informed and engaged multi agency cross sector workforce including policy makers and practitioners to deliver Welsh Government Policy
- Effectively influencing and contributing to policy and practice development with an emphasis on early intervention, prevention and mitigation of poverty, underpinned by Welsh Government strategic priorities

This report explains how these objectives were achieved through our work during 2014/15.



Young Wales

Cymru Ifanc – Young Wales is the participation work that is being funded by the Welsh Government Children and Families Development Grant over a three year period. The work began in October 2014.

Children in Wales leads Young Wales, with Voices from Care, Tros Gynnal, Promo Cymru and Youth Friendly as our partners. We also have a memorandum of understanding with Action for Children and Barnardos Cymru.



After some preliminary work meeting with youth forums and developing our online resources, Young Wales launched on Friday 27 March with young people from the forums across Wales meeting in Newtown to decide their priorities for the year.

This included the launch of a new website, www.youngwales.org.uk, and a dedicated Twitter account, @YoungWalesCIW.



The priorities identified by forums were:

- Healthy relationships
- Online safety
- Mental health
- Bullying and hate crime
- Substance misuse
- Raising awareness of children's rights

Young Wales works with a number of other organisations such as the NSPCC, the Travelling Ahead project and NUS Cymru to support and promote their work. Schools, other youth groups and individuals will also be feeding into our work as it develops. We will also facilitate young people from Wales taking part in the UK Youth Parliament over the next year.

Young Wales will be working to ensure that children and young people are heard on issues that are important to them and affect them, and that they are heard by the Welsh Government.

Developing and supporting strong networks

Children in Wales facilitates networks which bring professionals together to discuss policy and practice issues. They are vital to our work as they help us to understand issues of concern affecting organisations across the children's sector. Through these networks we can inform members of new developments, share good practice and develop appropriate perspectives on policy developments.

Cywaith - The Cywaith Management Board is a collaborative partnership of 5 organisations with responsibility for overseeing the management, operation and delivery of the MEIC telephone, instant messaging and text advice and support service for children and young people. Cywaith successfully tendered and secured the contract from Welsh Government to establish and deliver a new 24hr advocacy and advice service. Children in Wales have additional Chairing responsibilities for the Cywaith consortium

The Advocacy Practice Exchange Group provides an opportunity for practitioners in the field to share practice, experience and knowledge about advocacy and related areas. It contributes to the improved development of advocacy practice across Wales.

The All Wales Children and Young People's Advocacy Providers' Network contributes to and supports the development of effective advocacy in Wales. It aims to promote partnership work and developmental strategies between organisations. It facilitates problem solving and resolves potential conflicts of interest.

The Third Sector Additional Needs Alliance (TSANA) Is a group of voluntary organisations which seek to protect and promote the rights of children with additional needs in Wales. The aim of the group is to work with the National Assembly for Wales and Welsh Government to influence policy, to ensure that children with additional needs reach their full potential. Children in Wales chairs and facilitates this group.

The Children and Families' Practice Exchange Group meets regularly in South Wales to enable practitioners to share expertise and information on a range of issues concerning children's rights.

The Children and Young People's Rights Practice Exchange Group enables practitioners in North Wales to meet regularly to share expertise and information on a range of issues concerning children's rights.

The Forum for Integrated Service Delivery brings together professionals across Wales who are leading the development of the Team Around the Family, as part of the Welsh Government's Families First programme. The aim of the forum is to offer peer support to managers involved in developing localised services. It also allows professionals to share good practice and information in the development of early intervention and preventive services across Wales.

Linc3 supports the third sector with issues relating to children, young people and families. It enables representatives from Councils for Voluntary Services to improve knowledge and offer mutual support and understanding in order to enhance their work within Children and Young People's Partnerships. The members champion third sector representation and the promotion of children's rights.

The Disabled Children Policy Group brings together those with a policy brief on disability to highlight issues and concerns about services for disabled children. The group aims to influence public policy and scrutinise legislation in Wales in the interests of disabled children and young people.

The Looked After Children Health Exchange is a multiagency group which aims to help guide policy across Wales to promote the health of children looked after. It also operates as a forum for sharing practice and information.

The Parenting Co-ordinator's Network is a network for those who have a strategic co-ordinating role for parenting support in their Local Authority. The quarterly meetings give co-ordinators a chance to share issues, solutions, research and policy with their colleagues.

Children in Wales Preventing Bullying Behaviour
Group was set up to ensure that policies relating
to the anti-bullying agenda, both in schools and
communities, are evaluated and joined up. The group
meets to create a strong voice to challenge and
support anti-bullying work nationally and locally. It
also provides an opportunity to share practice and
identify common concerns.

The End Child Poverty Network Cymru is a coalition of organisations concerned with child poverty. It was set up in November 2001 and works to increase public and professional understanding of child poverty in Wales and measures to end it. It lobbies for policies at all levels of government which contribute to ending child poverty in Wales.

The Flying Start Network meets quarterly, bringing together the Flying Start Co-ordinators from the 22 Local Authorities. Additional meetings and workshops are also organised as needed. The Flying Start Network includes all managers of the programme in Local Authorities as well as Welsh Government managers.

The Young Carers Workers' Network meets three times a year, and also holds sub-group meetings on specific topics. The network is open to all those who work with young carers in Wales. The Network shares issues, concerns and supports the development of good practice. The Network also supports a young carers network who meet to identify key issues of concern and has the opportunity to present their concerns to the Deputy Minister for Social Services on an annual basis.

The Child Accident Prevention Practice and information Exchange (CHAPPIE) Network promoted the prevention of accidents and unintentional injuries for children and young people in Wales. It supports practitioners, managers and policymakers in their roles relating to injury prevention. This network came to an end at the end of March 2015.

Producing and disseminating information

Children in Wales produces a wide variety of information to help keep its members informed and up-to-date.

Children in Wales websites

The Children in Wales website (www.childreninwales.org.uk) is updated daily. It provides news updates from ourselves, our members and the wider children's sector. The policy section of the website contains updates on legislation and other developments affecting children and young people in Wales and the UK.

Young Wales website

The Young Wales website (www. youngwales.org.uk) was developed between January and March of 2015 to support our participation work. It is a hub of information on the work being undertaken by young forums, schools, partner organisations and individuals. The website also allows us to share information on Young Wales' work and opportunities for young people to get involved and have their voices heard.

E-briefing services

Our members' e-briefing is

circulated monthly. It keeps our members up-to-date with the latest policy developments and news. The Policy e-briefing is distributed to over 3000 individuals, and feedback from members shows that it is also shared much more widely within the children's sector in Wales. We also produce regular e-briefings for the End Child Poverty Network and the Family Information Services network.


Twitter

@youngwalesCIW. This will be used as another tool of engagement with young people and the workforce.


Children in Wales Magazine

Policy, practice, development and research

Much of Children in Wales' work involves promoting policy and practice development. During 2014/15 we carried out a whole spectrum of activities promoting policy and practice development across a range of areas. These included:

Bullying

Children in Wales' Preventing Bullying Behaviours Group (PBBG) developed four 'Jigsaw Workshop' events delivered across Wales this year. The Jigsaw workshops were themed events that focussed on different aspects of bullying; Understanding, preventing, intervention and attitudes. The issues

raised at these events have included:

Inconsistency on understanding of bullying and policy across authorities and sectors
Insufficient training for practitioners and teachers and wider school community including parents
Lack of resources particularly targeted resources for working with target, bully and bystander.

Next year the PBBG plan to develop a young people's anti bullying network.

A newly established Welsh Government All Wales Anti Bullying Leadership Group will be accountable to the Ministers for Education and Skills, Communities and Tackling Poverty and Local Government and Government Business. It has been established to help tackle bullying of children and young people in schools and the wider community. Its work will be informed by the recent report from Estyn on the effectiveness of action taken by schools to address bullying on the grounds of pupils' protected characteristics and by 'Tackling Hate Crimes and Incidents: A Framework for Action'. Children in Wales is a Third Sector Representative and young people's representative on the group.

Family support and parenting

Our kinship care guide was published in November 2014. It was sponsored by the Welsh Government and developed by Children in Wales.

The Guide is designed to offer information to kinship carers. Kinship carers may also be called family and friends carers. It aims to offer a step by step guide through the process of becoming a kinship carer, signposting the services that can offer advice, support and assistance.

Children in Wales held a conference for Parents Week in 2014. This year, the theme conference looked specifically at strengthening the contribution of parenting support services to early intervention family support. Participants considered key messages from speakers about early intervention research, including the main principles and ingredients of successful parenting programmes.

Children with Additional Learning Needs

Children in Wales is chair of TSANA (The Third Sector Additional Needs Alliance) a group of voluntary organisations which seek to protect and promote the rights of children with additional needs in Wales. Throughout 2014/15 we have worked with the Welsh Government, Assembly Members and other organisations to influence legislation, policy and practice in Wales to ensure that children with additional needs can access the support they need to reach their full potential. The Children in Wales development officer gave a presentation to the Minister for Education and Skills on this issue at a Third Sector Partnership Council meeting which resulted in the setting up of a Third Sector Additional Needs Alliance/ Welsh Government Task and Finish Group on Additional Learning Needs Reform in 2015. The role of the group was to bring together TSANA) representatives with Welsh Government officials to act as a 'critical friend' by providing ideas, proposals and suggestions to support the development of the proposed Bill on Additional Learning Needs (ALN) and in particular, the accompanying draft Code on ALN.

Social Services

Children in Wales were represented on the technical groups that contributed to the development of the regulations made under the Social Services and Well-being (Wales) 2014 Act and Code of Practice / statutory guidance. These included the Population Assessment and Prevention Technical group where members' views on the importance of ensuring that community preventative services were fully resourced was shared. Children in Wales's staff

also delivered awareness raising sessions on The Act and fully engaged with members during the consultations on the draft Codes of Practice.

Poverty

In December of 2014, Children in Wales launched our report, *Breaking the Cycle of Disadvantage*, as part of the UK Alliance for Investing in Children . This report outlines the principal legislation, policies and programmes for tackling child poverty and breaking the cycle of disadvantage in England, Wales, Scotland and Northern Ireland. The project formed part of the wider European work on implementing the European Commission Recommendation: Investing in Children - Breaking the Cycle of disadvantage. A conference was also held in December to share best practice from across the four nations.

Accident prevention

During the spring of 2014, Children in Wales worked with the British Medical Association in Wales and Public Health Wales to campaign about the risks of using disposable nappy sacks, which pose a serious risk of suffocation to babies. Bilingual posters and leaflets were created as part of this campaign and distributed throughout Wales.

Raising public and professional awareness

The Media and presentations

Through the media we are able to publicise our own work and the concerns that we have about issues affecting children and young people in Wales. During 2014/15 we sent out a number of press releases about our events, publications and other issues.

Children in Wales' staff have taken part in media interviews to television and radio, both local and national, and to a range of print media outlets. We have also given presentations to smaller groups, as well as larger conferences, about our work and specific areas of concern to a variety of groups both locally and internationally.

Events

Our conferences and events provide a forum to bring the workforce together to raise awareness and share best practice. Our events aim to highlight pertinent issues concerning children and young people in Wales.

During 2014/15 we hosted a broad range of successful conferences and workshops across Wales. These looked at topics including child poverty and wellbeing; early intervention and parenting;

early years and childcare; supporting Welsh speaking disabled children; and preventing bullying behaviour.

Training

Children in Wales provides a programme of multi-disciplinary training courses that are open for our members and the wider public to attend. These promote an integrated approach for all those working in the statutory, third and independent sectors. The courses draw on the resources of our own specialist staff team and a national network of expert individuals and organisations, to deliver high quality training across Wales. Children in Wales is an accredited training centre though Agored Cymru. We also provide tailored commissioned training for organisations on request.

Help desk and signposting services

Children in Wales has an information and signposting service for members of the public and professionals in the children's sector. We received over 200 inquiries during 2014-15. This involved advising people on childcare and accessing the Flying Start programme, child protection, parenting, child poverty, and contact issues.

Training

Children in Wales provides training for professionals working in the children's sector in Wales. This includes open training courses and tailored training commissioned by outside agencies.

Children in Wales open training

During 2014/15 Children in Wales ran a busy and successful programme of open training. Our training brochure featured an ambitious range of training including new topics as well as those which had been run successfully in the past. Topics included child protection, e-safety, working with fathers, cultural awareness in safeguarding, supporting parents, working with groups and building resilience in young people.

Commissioned training

Children in Wales regularly provides in-house training for organisations wanting a bespoke service.

Core topics that Children in Wales provide training on include child protection, building resilience in young people, working with significant males and accident prevention in the early years, although we also provide in-house training on any of the topics advertised in our open training programme.

Child protection training for dental practitioners

Children in Wales delivers child protection training to the Wales Deanery for Post-graduate Education for Dentists. We are contracted to provide Level 2 Child Protection training, in-house, to all staff within dental practices and at Post-graduate Centres in Wales. We delivered 88 child protection training sessions to dental practitioners across Wales between April 2014 and March 2015.

Cardiff Workforce Development

Children in Wales has continued our successful work with Cardiff Workforce Development, delivering child protection training to child minders and staff working in nurseries and after-school clubs in Cardiff. During the year we delivered 12 half day sessions on raising awareness in child protection to approximately 200 staff working with children, and we also delivered six 2 day Accredited Level 3 courses in Understanding how to Safeguard the Well-being of children and young people, to over 100 staff.

Accredited Training Centre

Children in Wales has achieved centre status to run Accredited training courses with Agored Cymru as our awarding body. We received an excellent report from Agored Cymru following our first full year as an accredited centre, with the Quality Reviewers noting:

"The centre use an impressive and generally user-friendly online system for learners to capture evidence of assessment, and staff to evidence an effective internal quality assurance process.... The role of the internal verifier is straightforward because of the competence, attitudes and professionalism of the assessors. Learners are well supported and feedback to learners is positive, relevant, constructive and developmental."

UNCRC Train the Trainer sessions for Professionals

Children in Wales successfully delivered a series of Train the Trainer sessions under the Welsh Government duty to increase awareness of the UNCRC (Article 42). This involved 22 full one day training courses with 274 delegates.

Including Families Project

Including Families was a project managed by Children in Wales, with funding from Big Lottery, working with Asylum Seeking, Refugee and Migrant families and communities to protect and safeguard children in these families. The Project began in late 2011 and ran until October 2014, to raise awareness and understanding of how to protect and promote children's wellbeing, including positive parenting methods to improve parenting and communication within families and keeping children safe and secure in their home environment.

The Project aimed to increase levels of understanding, within families and communities, of their crucial role in children's safety, wellbeing, education, health and development. This included making them aware of child protection law and practice in Wales, relevant to people who have arrived from different countries and cultures.

As well as working with community groups, the project offered awareness raising sessions for professionals and practitioners working in education, social care and health, on the specific challenges in safeguarding children in asylum, refugee and migrant communities. These sessions covered specific forms of child abuse that might occur in families and communities and awareness of different cultural practices that may cause concerns for practitioners. Although the project has now ended, training on cultural awareness in safeguarding children is still available through Children in Wales training.



INCLUDING FAMILIES PROJECT

To complement the work of the project, Children in Wales developed a website, which has a range of multi-lingual resources, giving information for families, communities, individuals, organisations and professionals who engage with asylum, refugee and migrant families, about issues and concerns affecting these families and their children. The website will continue to be available until 2016 and can be found at www.includingfamilies.org.uk.

During the final period of the project, between April and October 2014, when the project closed, a lot of training days and workshops were delivered to asylum seekers and refugees, third sector organisations and also to the UK Visa & Immigration housing providers. The project development worker was heavily involved in the organisation and delivery of Refugee Week in 2014, which included organising for a group of asylum seeking children to give a presentation to the Minister for Communities and Tackling Poverty at the Refugee Week launch event at the Senedd.

The highlight of 2014 was the end of Project conference, also held during Refugee Week. The conference was open to refugees, asylum seekers and migrants, as well as professionals and practitioners from a range of statutory and third sector organisations. The conference involved a combination of speaker presentations and workshops. Lunch was a multi-cultural extravaganze, with food from

across the world and we were privileged to be joined by Jeff Cuthbert, the then Minister for Communities and Tackling Poverty; the whole day was hailed as a success.



Together 4 Rights



The Children in Wales 'Together 4 Rights' (T4R) group aims to bring young disabled people from across Wales together and give them opportunities to:

- Meet and have fun
- Understand their rights
- Raise issues of concern in their everyday lives
- Have a voice in decision-making affecting themselves and their peers
- Build their capacity, by increasing their confidence and self-esteem, to become active members of their local communities



Together 4 Rights has been involved in several events this year. At the end of January, 15 members of the Dynamic Future group in Wrexham came together for a day's accredited training on 'Young People's Participation – Having a Voice'. The aim of the Dynamic Future project is to support young disabled people aged 14-25 who are not in receipt of a transition service. This was the third accredited training session run by Together 4 Rights with the aim of empowering young disabled people and helping them gain a better understanding of participation and their right to have their opinions listened to and taken into account.

Members of Together 4 Rights from across Wales came together in the autumn to participate in a full day's drama workshop on disability hate crime. The workshop was delivered by Taking Flight Theatre Company as a pilot for their production called 'Real Human Being', before its formal launch that took place in October.

'Real Human Being' is a forum theatre production and explores the issues around disability hate crime and its impact on victims. It is a three year project, funded by Welsh Government's Equality & Inclusion grant.

This year's activities were funded by Lloyds Bank Foundation and we are grateful to them for providing the financial resources that enabled T4R to continue to work with young disabled people across Wales.


