State of Children's Rights in Wales

This year marks the start of the journey towards the next examination of government's progress in implementing the UN Convention on the Rights of the Child (UNCRC).

As part of the State of Children's Rights in Wales project, Children in Wales organised two events in August 2020 to build knowledge and capacity amongst civil society in Wales of the UNCRC and reporting mechanisms.

The events also provided an opportunity to consult on eight thematic priorities to supplement our Call for Written Evidence to inform the report on priority issues to the UN.

To complement the information which was sent to each delegate, in advance of the event, we are providing a response to many of the questions and comments raised at the events and in the 'chat' facility, together with additional information which we hope will be of interest.
