



**DRAFT MINUTES**

**1. Introduction & Welcome**

The Chair, Dave Williams, welcomed members to the 2021 Annual General Meeting (AGM) and thanked them for their attendance. He noted that this AGM was once again being held online, commenting on the importance of continuing to find opportunities for networking.

It was noted that the AGM was quorate.

**2. Apologies for Absence**

A list of those who had given apologies for their absence is attached to these minutes, along with a list of attendees and proxy votes.

**3. Minutes from AGM, 13 October 2020**

It was agreed that the minutes were accurate, and were unanimously accepted as a true record of the proceedings by all those present. There were no matters arising.

**4. Presentation of Accounts including appointment of Auditors**

Suman Bhogal (Treasurer) presented the Annual Accounts 2019/20 to the members, noting that they have been scrutinised by the Independent Auditors, Azets.

The Treasurer asked those present to turn to page 20 of the annual report and accounts, where the Auditors confirm that the financial statements provide a true and fair view of

the state of Children in Wales' affairs. They also confirm that the accounts have been prepared in accordance with accounting practices and the Companies Acts.

The Treasurer then drew the attention of those present to page 23, reporting that the charity's income for the year was £1.28 million against an expenditure of £1.34 million, noting that further detailed breakdown of expenditure can be found on page 33 of the accounts.

She reported that there has been a net financial gain on investments of £59,000, resulting in an overall net loss of £13,600 for the full year position.

The Treasurer also reported that there has been a loss in the pension fund of £633,000 which has resulted in the pension reserve balance at year end being a £1.8m deficit. She noted that a more detailed breakdown can be found on page 38 of the accounts.

The Treasurer then thanked Owen Evans, Chief Executive, Cathy Groves, the Finance and Operations Director and all the team on a successful year.

The Chair reported that the organisation adapted well to the difficult situation last year, applying for grants to help. The Chair assured members that, in relation to the pension fund, the deficit is regularly reviewed by Trustees at the F&HR Committee meetings. He noted that, while there are concerns around the deficit and value of the fund, it is a complex situation. He thanked the Finance Team for presenting the organisation's accounts so clearly to Trustees throughout the year, as reflected in the Auditor's Report.

#### **4.1 Approval of the Accounts 2020/21**

The approval of the Accounts was agreed by all those present with no objections.

#### **4.2 Appointment of Auditors for 2021/22**

It was proposed that Azets continue as Auditors for 2021/22. All those present agreed with no objections.

### **5. Chief Executive's Report**

The Chief Executive, Owen Evans, drew the attention of members to the organisation's Annual Report, to be circulated immediately after the meeting.

The Chief Executive continued by explaining that it had been a very challenging year, as summarised in the organisation's financial accounts. He noted that the story could have been a lot starker but thanks to Cathy Groves, the Finance and Operations Director and colleagues, the organisation had been able to reduce spending and had been successful in applying for grants through WCVA and the Government's Furlough Scheme.

He reported on the huge amount of work required, virtually overnight, in re-working plans and delivery methods and thanked all the staff for the way they stepped up to the challenge.

He described how the work with the networks and with Young Wales moved online. He thanked the training team, acknowledging the work they had done in such a short time to adapt to the situation, re-working sessions for delivery online in an engaging way.

The Chief Executive continued by highlighting how Young Wales had engaged with a number of Ministers online, noting that this mode had worked well in allowing young people to come together from across Wales. Three meetings held with the First Minister addressed the impact of Covid-19, and children and young people had provided forthright feedback. The First Minister had referenced these meetings at his press conference, noting how they had affected decision making.

The Chief Executive thanked all the staff members for their continued engagement. He also thanked the Chair, Dave Williams and all the Trustees for their support and guidance during his first year in the role.

The Chair also thanked the Chief Executive, noting how difficult it had been to come into post during the pandemic. He noted the adaptions over the past year, and that these would now be built on going forward. The Chair thanked all his fellow Trustees and, on their behalf, thanked all the staff of Children in Wales for their work during the year.

## **6. Results of the Election to the Trustee Board**

The Chair reported that, following a call to members, five nominations were received for the three vacancies on the Trustee Board. A ballot had therefore been carried out and the following three were elected to the Trustee Board:

Helen Mary Jones (individual member)  
Bethan Webber (Home Start Cymru)

All those present accepted the election results unanimously.

The Chair congratulated the three nominees on their election to the Trustee Board with effect from this AGM.

## **7. Outgoing Trustees**

Jane Newby, University of South Wales (after two terms of office)  
David Egan, Cardiff Metropolitan University (after two terms of office)  
Diane Daniel (after 5 years as co-opted Trustee)

The Chair recorded particular thanks to all of the outgoing Trustees for their contributions to the organisation over the last years, noting that representation from the education sector has been part of the ‘DNA’ of Children in Wales. He thanked Trustees for their additional work on the Finance & Human Resources Committee.

The Chair noted particular thanks to Diane Daniel, who had provided much appreciated support to the staff of Children in Wales during the pandemic before a new Chief Executive was in post.

#### **8. Any Other Business**

There was no other business and the Chair closed the Annual General Meeting by thanking the members for their support and contributions over the year and all those present for their attendance.

Cyflwynodd Suman Bhogal (Trysorydd) Gyfrifon Blynnyddol 2019/20 i'r aelodau, gan nodi bod yr Archwilwyr Annibynnol, Azets, wedi craffu arnynt.

Gofynnodd y Trysorydd i'r rhai a oedd yn bresennol droi at dudalen 20 o'r adroddiad a'r cyfrifon blynnyddol lle mae'r Archwilwyr yn cadarnhau bod y datganiadau ariannol yn rhoi darlun cywir a theg o faterion busnes Plant yng Nghymru. Maent hefyd yn cadarnhau bod y cyfrifon wedi'u paratoi yn unol ag arferion cyfrifyddu a'r Deddfau Cwmnïau.

Yna, tynnodd y Trysorydd sylw'r rhai a oedd yn bresennol at dudalen 23, gan ddweud bod incwm yr elusen am y flwyddyn yn £1.28 miliwn o gymharu â gwariant o £1.34 miliwn, a dywedodd fod dadansoddiad manwl pellach o'r gwariant ar gael ar dudalen 33 o'r cyfrifon.

Dywedodd fod yr elw ariannol net ar fuddsoddiadau yn £59,000, gan arwain at golled net cyffredinol o £13,600 am y flwyddyn.

Dywedodd y Trysorydd hefyd fod £633,000 o golled yn y gronfa bensiwn sydd wedi arwain at ddiffyg net o £1.8m yng ngweddill wrth gefn y gronfa bensiwn. Nododd fod dadansoddiad manylach ar gael ar dudalen 38 o'r cyfrifon.
